Within this newsletter we want to introduce some partners of the LIFE EUROKITE project to you.

### **Pro Vértes Public Fundation**



Pro Vértes Foundation was established in 1991, in order to solve the nature protection issues arising in the Vértes region within a not for- profits frame. The scope of our activities has been widened through the past years, as a result of our successful and ever more secured activities, has started and continued to date the following programmes: nature protection management; nature-friendly land-management; education and awareness-raising; the protection of historical buildings; eco-tourism; operation of the Vértes Nature Park. Pro Vértes Nonprofit Zrt. serves as the Foundation's sevice ltd. for these tasks since 2009.

The first programme of Pro Vértes was bird protection, which primarily aimed at the saving of the population of strictly protected endangered birds of prey (Imperial Eagle and the Saker) inhabiting Fejér County. The proof of the success of our efforts is that the populations of these birds have stabilized in the region by now. Among our methods the most important ones are the placement of artificial nests, winter feeding, insulation of medium voltage electric poles.

The red kite was mainly a breeding bird in the lowlands in the first half of the 20th century. From the 1950s to the early 1970s there was a very small number of red kites that brooded in the low mountain range. Then local extinction followed. In 1990 the first breeding pair appeared again. In 2017 the breeding population increased to 12 breeding pairs, in 2018 to 15 breeding pairs and in 2019 to 18 breeding pairs in Hungary. In 2020 the number of breeding pairs had already increased to 25. The most important protective measure is to ensure the breeding success of the broods by identify protection zones.

# **Raptor Protection of Slovakia**



Raptor Protection of Slovakia (RPS) is a non-profit, non-governmental organization, whose mission is to contribute to the conservation of biodiversity, with special regard to the conservation of raptors, owls and their habitats in accordance with the principles of sustainable development.

RPS activities are focused on 4 program areas:

- (i) survey and on-site protection of birds of prey and owls and their habitats,
- (ii) addressing bird crime, electrocution and bird collisions with power lines,
- (iii) lobbying for sound biodiversity policies, strategies, incentives and conservation management plans, and
- (iv) environmental education and awareness.

RPS started as informal Group for Research of Raptors and Owls in 1975 and transformed into organisation with the same name in 1999. Since 2004 it is known as Raptor Protection of Slovakia. RPS has ca 120 members that act in the whole Slovakia, mostly on voluntary basis. Their activities are coordinated by the RPS Secretariat in Bratislava. RPS cooperates with a range of partners from both public and private sector.

In Slovakia, Red Kite breeds in the western and eastern part of the country, at altitudes from 100 to 600 m above sea level. Abundance of the breeding population is estimated at 20 – 30 pairs. The majority of the breeding population is concentrated in the Záhorie region in western Slovakia. Abundance of the wintering population is estimated at 50 – 150 individuals. The most significant threats to the population are inappropriate forestry activities in the breeding habitats (in particular logging and construction of the forest roads), laying poisoned baits and disturbance (mainly from fishing and hunting activities). Other threats include inappropriate agricultural practices in feeding habitats (eg. chemization, cultivation of unsuitable agricultural crops, meadow plowing, burning of grasslands and stubble) and illegal shooting. Cases of injuries and deaths of specimens resulting from electrocution on 22 kV power lines have been also occasionally reported.




